As part of the FMC Freedom Pass program, growers who commit to purchase minimums of qualifying products receive a 3RIVE 3D application system at no initial cost. Growers have a maximum of three years to meet the total volume commitment.

Growers who would like to participate in this program but cannot meet the total volume commitment for primary products may instead substitute the alternative FMC products and volumes listed below. 3RIVE 3D brand pesticides must be greater than or equal to 70 percent of total purchase requirements.

No penalty for achieving volume commitments in less than three years. Growers may purchase any volume over the minimum annual requirement so long as the total volume commitment is achieved in not more than three years. If product purchase annual minimum is not met, grower agrees to pay the balance according to the formula below: Commitment Gallons – Purchased Gallons X \$85/gallon Example: 105-gallon commitment - 75 gallons purchased = 30 gallons X \$85 = \$2,550 owed to FMC
