



# Mustang<sup>®</sup> Maxx Insecticide or Hero<sup>®</sup> Insecticide Early Corn Pest Preventative Assurance Program

## Program Overview

The 2019 Mustang<sup>®</sup> Maxx insecticide or Hero<sup>®</sup> insecticide Early Corn Pest Preventative Assurance Program is designed to provide growers with the best protection when they use Mustang Maxx insecticide and Hero insecticide pre-emergent to control cutworm, true armyworm or common stalkborer in corn.

The Assurance Program covers growers who apply Mustang Maxx insecticide for corn at a minimum of 2.56 fl. oz./A or Hero insecticide at a minimum of 2.6 fl. oz./A in accordance with label directions. Through June 1, 2019 growers will be eligible to receive reimbursement for a second Mustang Maxx insecticide application if the initial treatment fails to provide commercial control of soil cutworms, true armyworm, or common stalkborer.

To be eligible, growers need to contact their FMC Retail Market Manager or Star Retailer before making additional applications of Mustang Maxx insecticide.

<b>Payment Rate:</b>	Cost of a second Mustang Maxx Insecticide at 2.56 fl. oz./A <u>or</u> Hero insecticide at 2.6 fl. oz./A treatment, plus up to a maximum of \$5.00/acre for custom application.
