FMC assures Anthem® Flex herbicide provides 85% control up to 60 days after application in wheat for downy brome, Italian ryegrass and rattail fescue.

FMC Anthem Flex Herbicide PNW Respray Assurance Guide:

Anthem Flex herbicide is a highly effective herbicide for the control of downy brome, Italian ryegrass and rattail fescue in fall-planted wheat when used according to label directions. Apply 2.7-4.5 ounces (see chart below) of Anthem Flex herbicide per acre as a preplant or post plant preemergence to wheat. Preplant and post plant preemergence applications may be applied where allowed by the label i.e., Idaho, Montana, Oregon and Washington.

Program Requirements:

FMC assures 85% control up to 60 days after application for downy brome, Italian ryegrass and rattail fescue if the following conditions are met:

- Wheat is planted on a clean seedbed with no Italian ryegrass, rattail fescue or downy brome germinated. Glyphosate or other effective non-selective grass herbicides may be used to assure no downy brome is present at planting.
- Anthem Flex herbicide is applied as a preplant or post plant preemergence as described on the label.
- The correct label rate is applied according to target weed and soil texture. Products must be applied according to label use directions.
- At least 0.5 inches of rainfall occurs within 10 days after application.
- Grower must have an untreated check to validate weed control. Use identical seed varieties or hybrids, fertility, tillage, seeding rate and weed control programs in all comparison check strips.
- Record and save product lot or batch numbers.
- **Grower must provide a product application record and product purchase invoices.**
- In the event a grower does not achieve at least 85% control up to 60 days after application, FMC will pay up to \$8.00 per acre toward the cost of a postemergent herbicide application.
- Growers must sign agreement to participate in this assurance program **no later than November 1, 2019.**
- If there is a concern about return on investment, you must contact your FMC representative no later than **May 1, 2020.**
- To be eligible for this program, growers need to contact their FMC retail market manager or FMC Star Retailer before making an application of a postemergent herbicide.
