PROGRAM DESCRIPTION

Anthem® MAXX herbicide provides outstanding residual activity with excellent broad-spectrum grass and small-seeded broadleaf performance and is strong foundation for corn acres. Anthem MAXX herbicide has great flexibility and can be utilized preplant, preemergence and early postemergence in corn and will provide an additional two to three weeks of weed control on grasses and small-seeded broadleaves beyond what other corn residual herbicides can deliver.

Growers that follow the guidelines of the **2020 Anthem MAXX Herbicide Corn Assurance** at the minimum specified rates will be eligible for an assurance payment up to \$10/A if the FMC recommendation does not maintain commercially acceptable 90% control of labeled weeds versus an untreated check. Any assurance claim must be reported within 30 days of last application.
