



2021 Mustang® Maxx Insecticide or Hero® Insecticide Early Corn Pest Preventative Assurance

PROGRAM DESCRIPTION

The **2021 Mustang® Maxx insecticide or Hero® insecticide Early Corn Pest Preventative Assurance Program** is designed to provide growers with the best protection when they use Mustang Maxx insecticide or Hero insecticide as a preventative treatment prior to or after planting to control cutworm, true armyworm or common stalk borer in corn.

The Assurance Program covers growers who apply Mustang Maxx insecticide for corn at a minimum of 2.56 fl. oz./A or Hero insecticide at a minimum of 2.6 fl. oz./A preplant surface or preemergence in accordance with label directions. Through June 1, 2021, growers will be eligible to receive reimbursement for a second Mustang Maxx or Hero insecticide application if the initial treatment fails to provide commercial control of soil cutworms, true armyworm, or common stalk borer.

To be eligible, growers need to contact their FMC retail market manager or Star Retailer before making additional applications of Mustang Maxx or Hero insecticides.

Program Period:	October 1, 2020 – June 1, 2021
Program Geography:	AR, CO, DE, IA, IL, IN, KS, KY, MD, MI, MN, MO, MT, NE, NC, ND, NJ, OH, OK, PA, SC, SD, TN, WI, WY, W-VA, VA
Program Payment:	30 days after claim submission to FMC.
Payment Rate:	Cost of a second Mustang Maxx insecticide at 2.56 fl. oz./A or Hero insecticide at 2.6 fl. oz./A treatment, plus up to a maximum of \$5.00/acre for custom application.
